WVAIVER: In consideration of the acceptance of my entry in the St. Michaels Running Festival (Event), I, hereinafter the participant, for myself, my executors, administrators and assignees, hereby release and discharge Eastern Shore Endurance Events, LLC, the town of St. Michaels, Talbot County, event sponsors, event partners, event volunteers, event staff and associates of all liability for claims or damages, demands, actions or any other legal matter arising out of my participation in said athletic event.

ASSUMPTION OF RISK FOR BODILY OR PERSONAL INJURY AND ILLNESS. The participant acknowledges that running on roads, paths, trails and bridges is a potentially hazardous activity. The participant shall not enter and run in the Event unless the participant is medically able and properly trained. The participant agrees to abide by any decision of any Event official relative to their ability to safely complete the Event. The Participant assumes all risks associated with participating in the Event including, but not limited to, high heat and/or humidity, rainy or wet conditions, the conditions of the roadways and courses, all injuries or death that may be suffered by the participant before, during, or after the Event, all such risks being known and appreciated by me. Knowing these facts, and in consideration of your acceptance of the participants Event entry, the participant (and if participant is under 18 years of age, the parent or guardian of participant), for themselves, their spouse, heirs, personal representatives, and assigns, hereby waive, covenant not to sue, RELEASE and DISCHARGE Eastern Shore Endurance Events, LLC, the town of St. Michaels, Talbot County, event sponsors, event partners, event volunteers, event staff and associates, representatives and subcontractors; other participants; and any other sponsors, advertisers and, if applicable, owners, lessors and/or lessees of any premises on which the Event takes place (collectively, the "Event" Parties) from any and all liability, loss, damage, claim, action or demand arising from or attributable to my participation in and travel to and from this Event, including, but not limited to, liability that may arise out of negligence or carelessness of the Event Parties. The participant attests that they are physically fit and sufficiently trained for this, with said physical condition verified by a licensed M.D. during the last 6 months. The participant has read this agreement, fully understand its terms, understand that the participant has given up substantial rights by signing it and have signed it freely and without any inducement or assurance of any nature, and intend it to be complete and unconditional release of all liability to the greatest extent allowed by law, and further agree that if any portion of this agreement is held to be invalid that the balance, shall continue in full force and effect.

By signing this Waiver I, the participant, agree that all conflicts will be resolved through binding mediation-arbitration in the jurisdiction of Talbot County, Maryland. All participants understand that they are solely responsible for any tax liability associated with the receipt of any cash, gifts, prizes or in-kind benefits received from or by participating in the Event. I also understand that the race route will close promptly at 11am and there will be no further EMS or support services offered after this time.

PUBLICITY. The participant hereby releases to the Event(s) and its partners full and exclusive rights to record my performance in this race on film, videotape, or still photography for use without compensation to me.

NO REFUNDS. The participant understands that the entry fee is non-refundable and non-transferable (unless specifically stated on the online registration form). The participant also understands that the Event will take place rain or shine, at Race Director's discretion. The Race may also be canceled due to natural hazards or other factors not under the control of the Race Director. If race is cancelled for any reason, there are no refunds.
