WAIVER: In consideration of the acceptance of my entry into the St. Michaels Running Festival (hereinafter "the Event"), I (hereinafter "the participant"), for myself, my executors, administrators and assigns, hereby release and discharge Eastern Shore Endurance Events, LLC (and its parent companies and/or subsidiaries and/or DBAs), the town of St. Michaels, Talbot County, event sponsors, event partners, event volunteers, event staff and associates of all liability for claims or damages, demands, actions or any other legal matter arising out of my participation in the Event.

ASSUMPTION OF RISK FOR BODILY OR PERSONAL INJURY AND ILLNESS. The participant acknowledges that running on roads, paths, trails and bridges is a potentially hazardous activity. The participant shall not enter and run in the Event unless the participant is medically able and properly trained. The participant agrees to abide by any decision of any of the Event officials relative to their ability to safely complete the Event. The participant assumes all risks associated with participating in the Event including, but not limited to, high heat and/or humidity, rainy or wet conditions, the conditions of the roadways and courses, all injuries (up to and including death) that may be suffered by the participant before, during, or after the Event, all such risks being known and appreciated by the participant. Knowing these facts, and in consideration of the participant's entry into the Event, the participant (and if the participant is under 18 years of age, the parent or legal guardian of the participant), for themselves, their spouse, heirs, personal representatives, and assigns, hereby waive, covenant not to sue, RELEASE and DISCHARGE Eastern Shore Endurance Events, LLC (and its parent companies and/or subsidiaries and/or DBAs), the town of St. Michaels, Talbot County, event sponsors, event partners, event volunteers, event staff and associates, representatives and subcontractors; other participants; and any other sponsors, advertisers and, if applicable, owners, lessors and/or lessees of any premises on which the Event takes place (collectively, "the Event Parties") from any and all liability, loss, damage, claim, action or demand arising from or attributable to the participant's participation in (and travel to and from) the Event, including, but not limited to, liability that may arise out of negligence or carelessness of the Event Parties. The participant attests that they are physically fit and sufficiently trained for this, with said physical condition verified by a licensed M.D. during the last 6 months. The participant has read this agreement, fully understand its terms, understand that the participant has given up substantial rights by signing it and have signed it freely and without any inducement or assurance of any nature, and intend it to be complete and unconditional release of all liability to the greatest extent allowed by law, and further agree that if any portion of this agreement is held to be invalid that the balance, shall continue in full force and effect.

By signing this waiver I, the participant, agree that all conflicts will be resolved through binding mediation-arbitration in the jurisdiction of Talbot County, Maryland. All participants understand that they are solely responsible for any tax liability associated with the receipt of any cash, gifts, prizes or in-kind benefits received from or by participating in the Event. The Participant also understands that the race route will close promptly at 11am and there will be no further EMS or support services offered after this time.

PUBLICITY. The participant hereby releases to Eastern Shore Endurance Events, LLC (and its parent companies and/or subsidiaries and/or DBAs) and its partners full and exclusive rights to record my performance in this race using any and all forms of recording media for use at their sole discretion without compensation or notification to me.

NO REFUNDS. The participant understands that the entry fee is non-refundable and non-transferable (unless transfers are completed online within the designated web-based registration platform used by the Event). The participant also understands that the Event will take place rain or shine, at Race Director's discretion. The Race may also be canceled due to natural hazards or other factors not under the control of the Race Director. If race is canceled for any reason, there are no refunds.
